Born in Toronto, Raj is a dual Canadian-U.S. citizen. Raj holds the inaugural Leo. S. Brenneisen Distinguished Professorship (2017-present) at the University of Kansas School of Law, before which he held the Rice Distinguished Professorship (2003-2017). Both are university-level chairs, the highest scholarly accolade in Kansas. He served as KU's Associate Dean for International and Comparative Law (2011-2017). *Ingram's Business Magazine* designated him as one of "50 Kansans You Should Know" (https://ingrams.com/article/50-kansas-you-should-know-the-class-of-2020/).

Raj has taught full-time at The George Washington University School of Law (1998-2003), where he held a Chaired Professorship, and at William & Mary Law School (1993-1998), where he was voted tenure. He also has taught at the law schools at Auckland (where he was New Zealand's Legal Research Foundation Visiting Scholar), LaTrobe (Melbourne), across the Indian Sub-Continent, Hong Kong and Taiwan, Tel Aviv and the Gulf, and Duke and Michigan.

Raj practiced at the Federal Reserve Bank of New York, where he twice won the President's Award for Excellence thanks to his service as a delegate to the United Nations Conference on International Trade Law (UNCITRAL). He is Senior Advisor to Dentons U.S. LLP, the world's largest law firm, focusing on international and comparative legal matters. He is a member of the Speaker Program of the U.S. Department of State. A Harvard Law School graduate (*Cum Laude*), he completed Masters degrees, as a Marshall Scholar, at LSE and Oxford, and an undergraduate degree at Duke (*Summa Cum Laude*, *Phi Beta Kappa*) as an Angier B. Duke Scholar.

Raj has authored 14 books. His four-volume *International Trade Law: A Comprehensive Textbook* (5th ed., 2019), is one of the world's leading references in the field that over 100 law schools around the world have used (www.dropbox.com/s/78sagrsm4g30k4g/R%20Bhala%20Book%20Launch.mp4?dl=0). He also wrote the first treatise on GATT in nearly 50 years, the two-volume *Modern GATT Law* (2nd edition, 2013). And, he is the first non-Muslim American scholar to write a textbook on Islamic Law, *Understanding Islamic Law* (*Sharī'a*) (3rd edition, 2023).

Raj's newest books are on U.S.-China trade relations, *Trade War: Causes, Conduct, and Consequences of Sino-American Confrontation* (2024), and the Trans Pacific Partnership, *TPP Objectively: Legal, Economic, and National Security Dimensions of CPTPP* (2nd edition, 2019). His current book project is *Principles of Law, Literature, and Rhetoric: A Shakespearean Approach*. Raj also has authored and co-authored over 90 scholarly law review articles.

Media world-wide frequently call upon Raj. From January 2017-October 2022, "On Point" was his regular column on International Law and Economics, which Bloomberg Quint / BQ Prime (Mumbai) published (www.bqprime.com/author/92714/raj-bhala) and distributed to approximately 6.2 million readers worldwide.

Bhala serves on the Executive Board of Directors of the Carriage Club of Kansas City, and the Alumni Association Board of University School Milwaukee (his *alma mater*). He loves fitness cross-training, has finished 115 marathons, including the "Big Five" of the "World's Majors" (Boston twice, New York twice, Chicago twice, Berlin, and London), and enthusiastically studies Shakespeare and French. Case involving French company alleged to have dumped enriched uranium in the United States market. *Amicus* brief focused on whether the antidumping (AD) rules of the World Trade Organization (WTO) and United States apply to services, as distinct from goods. The brief argued they do not, a point with which the Court did not take issue. Justice Souter wrote for the Court, in a 9-0 decision. The Court held the Department of Commerce (DOC) reasonably treated the enriched uranium at issue as a "good" subject to AD law, rather than a service exempt under that law. As the Court focused on the *Chevron* standard of administrative review (deferring to the DOC's interpretation), it found no need to reach the issue addressed by the brief.

Case arising amidst the Sino-American Trade War raising the question whether the USTR has, under Section 301 of the Trade Act of 1974, as amended, the statutory authority to impose new tariffs on hundreds of billions of dollars of Chinese-origin imported goods, without regard for the detailed procedural and substantive limitations in relevant portions of Title 19 of the United States Code, just because China retaliated against the United States after USTR had imposed tariffs on \$50 billion in goods from China. In effect, at issue was the extent of Presidential authority under Section 301.
