Other Activity

Litigation

State Litigation (LSP), Our cases begin with correspondence from inmates. We begin a review process when we receive enough information. Some inmates we cannot assist at all. Others are reviewed to determine if they are sufficiently substantive for student review. If the case is not closed, it is assigned to a student intern for analysis. Some cases result in Project Litigation; others are closed.

In calendar year 2013, we administratively resolved 83 cases; rejected 171 cases and judicially resolved 5 cases. 59 cases were open at the end of the year. (January 1, 2013 - December 31, 2013)

USP Leavenworth, We assist inmates with federal habeas petitions and the resolution of outstanding minor criminal/traffic matters. Successful resolution of detainers allows the inmate to be eligible for additional treatment and early release.

In calendar year 2013, we administratively resolved 34 cases; rejected 34 cases; and 28 are currently open. (January 1, 2013 - December 31, 2013)

USP Leavenworth, We handle a number of misdemeanor cases, generally traffic, in a number of municipal courts. By resolving these outstanding cases for our federal clients, our clients are able to transition to halfway houses as they are released from prison. (January 1, 2012 - December 31, 2012)
