INTERNATIONAL LAW AND AGROECOLOGICAL HUSBANDRY: BUILDING LEGAL FOUNDATIONS FOR A NEW AGRICULTURE (Routledge, Earthscan Food & Agriculture Series, 2017). “Book #2” in the four-book series noted above, focusing (in this book) on the *legal* aspects of transforming global agriculture – and thereby building on the 2012 GRASSLANDS book (see below) and on research finished under a 2016 Fulbright Research Chair in Global Governance (Canada).

GLOBAL LEGAL REGIMES TO PROTECT THE WORLD’S GRASSLANDS (Carolina Academic Press, 2012). This book examines various legal regimes – those of Canada, China, Turkey, the USA, the EU, and the multilateral system of treaties – and evaluates efforts to arrest the rapid degradation of the Earth’s

grasslands biomes. The book proposes a program of action to accelerate efforts at protection and restoring those landscapes. This program of action revolves around transforming agriculture; hence books #2, #3, and #4 (above) in the four-book series.

### ***Global institutions***

LOSING THE GLOBAL DEVELOPMENT WAR: A CONTEMPORARY CRITIQUE OF THE IMF, THE WORLD BANK, AND THE WTO (Brill-Nijhoff, 2008). Building on earlier scholarship, this text contributes to the debate over globalization, and particularly over the role of the International Monetary Fund, the World Trade Organization, and the World Bank. The book is designed to reach policy-makers by bringing to the general reading public a broader understanding of those institutions and how they can be intelligently viewed and effectively harnessed.

THE ASIAN DEVELOPMENT BANK [appearing as a monograph in the INTERNATIONAL ENCYCLOPAEDIA OF LAWS series on INTERGOVERNMENTAL ORGANIZATIONS] (Kluwer Law International, 4<sup>th</sup> edition 2018, 3<sup>rd</sup> edition 2014, both with Xing Lijuan). This book offers a bird's-eye view of the ideological, historical, financial, operational, institutional, and legal aspects of what is widely regarded as the premier regional development bank.

THE FUTURE OF THE GLOBAL ECONOMIC ORGANIZATIONS: AN EVALUATION OF CRITICISMS LEVELED AT THE IMF, THE MULTILATERAL DEVELOPMENT BANKS, AND THE WTO (Transnational Publishers, 2005). This analytical monograph explores both the record and the prospects of the global economic institutions by examining numerous key criticisms directed at those institutions. Reflecting a quarter-century of work with international organizations, the book offers recommendations for their future.

### ***Comparative & Chinese law***

GREAT LEGAL TRADITIONS: CIVIL LAW, COMMON LAW, AND CHINESE LAW IN HISTORICAL AND OPERATIONAL PERSPECTIVE (Carolina Academic Press, 2011, 2<sup>nd</sup> printing 2014). This treatise, written both for an academic (student and researcher) readership as well as a more general audience, offers a comparative survey of three principal legal traditions, setting all of them in historical context that helps explain operational differences in countries that manifest them today.

LEGAL TRANSPARENCY IN DYNASTIC CHINA: THE LEGALIST-CONFUCIANIST DEBATE AND GOOD GOVERNANCE IN CHINESE TRADITION (Carolina Academic Press, 2013) (co-authored with Xing Lijuan). To examine the “hot” topic of legal transparency from a unique cultural and historical perspective, this book relies on Western and Chinese sources to explain how the competing ideologies of Legalism and Confucianism were melded in the 3<sup>rd</sup> century BCE to create a legal system that for two millennia balanced definitiveness with vagueness, and reflected cultural values still at work in China.

CHINA'S LEGAL SOUL: THE CHINESE LEGAL IDENTITY IN HISTORICAL CONTEXT (Carolina Academic Press, 2009). A central aim of this book is to explore modern China's law – and particularly its 30-year legal reform effort (1979-2009) – against the backdrop of the highly sophisticated dynastic legal tradition that collapsed a century ago. Special emphasis is placed on issues revolving around the rule of law and ideological foundations for today's Chinese society.

LAW CODES IN DYNASTIC CHINA: A SYNOPSIS OF CHINESE LEGAL HISTORY IN THE THIRTY CENTURIES FROM ZHOU TO QING (Carolina Academic Press, 2005) (co-authored with Yanping Wang). This book surveys the sweep of China's legal tradition as viewed from the perspective of one central theme: legal codification. The book aims to contribute to the professional academic literature in the area and to bridge the gaps in the approaches taken by historians, China experts, and lawyers.

GLOBAL BUSINESS LAW: PRINCIPLES AND PRACTICE OF INTERNATIONAL COMMERCE AND

INVESTMENT (Carolina Academic Press, 3<sup>rd</sup> edition 2012, 4<sup>th</sup> edition 2018). This is a treatise designed for students and practitioners of international business transactions. The main text is accompanied by an extensive documentary appendix. It is also accompanied by a Teacher's Manual.

GENERAL PRINCIPLES OF BUSINESS AND ECONOMIC LAW (Carolina Academic Press, 2008). This book surveys the network of norms governing business organizations, commercial sales, banking, insurance, employment, intellectual property rights, business competition, bankruptcy, environmental protection, accounting, tax, and more. In doing so, it explains certain basic concepts of business and economic law that hold true in most countries around the world, despite the diversity of legal systems and ideologies. 国际商事经济法律通则 [GENERAL PRINCIPLES OF INTERNATIONAL BUSINESS AND ECONOMIC LAW] (Renmin University Press, 2009) is a companion volume designed for use in Chinese law schools and accompanied by a reader's guide in Chinese.

PREVENTING FINANCIAL CHAOS: AN INTERNATIONAL GUIDE TO LEGAL RULES AND OPERATIONAL PROCEDURES FOR HANDLING INSOLVENT BANKS (Kluwer Law International, 2000) (co-authored with Robert Lee Ramsey). Drawn from experience in both the legal and the operational side of banking law practice in developing countries, this book offers explanations and normative recommendations about a central problem in many such countries – risks posed by weak banking systems.

A GENERAL INTRODUCTION TO ECONOMIC LAW (University of Wisconsin, 2007). This is the second edition of a book first published in both English and Bahasa Indonesia in 1997 under the joint authority of the Indonesian “ELIPS” legal-capacity-building project and the University of Indonesia Law Faculty. The revised edition, like the first one, is designed primarily for use in Indonesian law schools.
